#### **Boulder River Photo Adventure**

#### Saturday, April 28th, 2012



The falls that cascade into Boulder River lie in a deep dark canyon and bright sunny days create extreme contrast here making it difficult to photograph this subject. The weather for our outing was ideal for this location. Bright but overcast—no rain. We've had lots of rain this spring and record snow fall so there was an abundance of water flowing both in the falls and in Boulder River itself.

We left in the early AM and were the second car at the trailhead (highly recommended to be at this location early). Pretty much had the location to ourselves for most of the morning. By late morning the trail got busy and when we walked out to the trailhead the parking lot was full and cars were parked all along the side of the access road – this is a very popular spring hike as the trail is easy (much of it old railroad grade), and lots of families with children and dogs hike here and the falls at 1.2 miles are spectacular.



We enjoyed the quiet early morning walk in what is nearly a rain forest – trees draped in moss, goat's beard lichen hanging from the branches and lots of ferns beginning to unfurl. Photographing the waterfalls and river was our primary goal but there were small yellow wild flowers opening,

red current and salmon berry starting to bloom, a fair number of trillium and mushrooms and fungus that provided alternate photo opportunities. And ask David VanKeuren to see a picture of what is believed to be a mountain lion paw print he found along the river bank.

On the way home we stopped for lunch at Rhodes River Ranch in Oso. Obscure out of the way location but worth the stop.

## Nature Division (ND): Basics & Background

### **Definition**

All images used in PSA Nature Division competitions and PSA-recognized Exhibitions must meet the PSA Nature Definition of Nature Photography as follows:

Nature photography is restricted to the use of the photographic process to depict observations from all branches of natural history, except anthropology and archeology, in such a fashion that a well informed person will be able to identify the subject material and to certify as to its honest presentation. The **story** telling value of a photograph must be weighed more than the pictorial quality while maintaining high technical quality. Human elements shall not be present, except where those human elements enhance the nature story. The presence of scientific bands, scientific tags or radio collars on wild animals is permissible. Photographs of artificially produced hybrid plants or animals, mounted specimens, or obviously set arrangements, are ineligible, as is any form of manipulation that alters the truth of the photographic statement. No techniques that add to, relocate, replace, or remove pictorial elements except by cropping are permitted. Techniques that enhance the presentation of the photograph without changing the nature story or the pictorial content are permitted. All adjustments must appear natural. Color images can be converted to grayscale monochrome. Infrared images are not allowed.


# **Color Projected Image Division (CPID): Creative Interclub Competition**

This CPID activity is exclusively for Creative Photography. The PSA definition of Creative is "Altered Reality." More specifically, the image must obviously display a change in natural color, form, shape, or any combination of three. High Dynamic Range (HDR) images without further changes are not considered "altered reality."

The original image must be made by the entrant on photographic emulsion or captured digitally. All images must be original and may not incorporate elements produced by anyone else. Original images must be altered by the maker; artwork or computer graphics generated by the entrant may be incorporated, if the original photographic content predominates. Images may not be constructed entirely within a computer. It is necessary that the image's core content be identifiable. Noncreative images are not eligible for this competition. Any subject matter is acceptable as long as the Altered Reality guidelines are apparent.

## **Photo Travel Division (PTD): Basics**

**Definition** A Photo Travel image must express the feeling of a time and place, and portray a land, its people, or a culture in its natural state. Photo Travel images have no geographical limitations. Ultra close-ups, which lose their identity and studio-type model shoots, are unacceptable. Techniques that add to, relocate, replace or remove any element of the original image, except by cropping, are not permitted. Techniques that enhance the presentation of the image, without changing the photo travel content, are permitted. All adjustments must appear natural. The removal, or manipulation, of colors contained within the original image to enable the production of monochrome images is permitted.
